## **2018 Seasonal Information**

Seasonal sites are available for use by one immediate family consisting of two registered parents and 2 registered minor children, 2 registered vehicles. **Site fees do not include electric.**

<b><u>Rates:</u></b>	Water & Electric (w/e):	\$4200.00
	Full Hookup (FP 30/50 amp):	\$4650.00
	Winter Storage: trailer/boat	\$375.00 (starting winter 2018)
	Boat/Golf Cart	\$100.00
	Additional Vehicle	\$100.00

\$500 deposit and the \$300.00 winter storage will be due on September 15<sup>th</sup> of the 2017 season to assure returning seasonal campers sites. Failure to leave a deposit means your site is not guaranteed for the 2018 season and may be rented out.

### **Terms:**

**Plan A:** seasonal sites **Paid in full** by January 31, 2018 save \$100.  
*Save an additional \$50 by paying via check or cash.*

**Plan B: Three payments: W/E** **\$4200.00 -\$500 dep = \$700.**  
January 15<sup>th</sup> \$1233.33  
February 15<sup>th</sup> \$1233.33  
March 15<sup>th</sup> \$1233.33

**Three payments: FH** **\$4650.00 -\$500 dep = \$4150.00**  
January 15<sup>th</sup> \$1383.33  
February 15<sup>th</sup> \$1383.33  
March 15<sup>th</sup> \$1383.33

**Plan C:** Seasonal rates may be paid in 6 (six) equal payments from January to June for an additional cost of **\$200.00** per season.  
**Water/electric rate \$4400.00 Full Hookup \$4850.00. Prior notice must be given when choosing Plan C.**

**All seasonal campers must fill out and return a contract with 1<sup>st</sup> payment. A contract must be on file and site paid in full before March 15<sup>th</sup> to receive your gate keys.**

If first payment is not received by January 31<sup>st</sup> site will be considered available for rent. Any seasonal site with a balance on March 15<sup>th</sup> will be assessed a **\$25.00 late fee** per week. With the exception of those choosing Plan C. Late Fees for plan C will begin accruing as of June 15<sup>th</sup>.

**\*\*\*Note:** Anyone with an outstanding balance from previous season (including winter storage or electric bills) will have their first payment applied to the 2017 balance before the 2018 balance. Please be aware of this as it may mean your 2018 balance will begin accruing late fees as of March 15<sup>th</sup>.
